RELEASE AND WAIVER

In consideration of the service of RELYANT ENTERTAINMENT LLC dba The Jumping Jungle, its agents, owners, officers, representatives, employees, volunteers, participants, I hereby agree to release and discharge RELYANT ENTERTAINMENT LLC dba The Jumping Jungle (hereinafter collectively Relyant Entertainment LLC) on behalf of myself, the participant(s) identified below, my parents, my heirs, assigns, personal representative and estate, and hereby acknowledge and agrees as follows:

This release and waiver covers risks of death, serious injury and property loss whether arising from (i) negligence or carelessness on the part of the persons or entities being released and other participants, or (ii) dangerous or defective equipment.

Express Assumption of Risk: I expressly agree and promise on behalf of myself and any of the minors for which I am responsible, to accept and assume all the risks existing in this activity. My/our participation in this activity is purely voluntary, and I/we elect to participate in spite of the risks. Indemnity: Should GS3K LLC or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree on behalf of myself and any of the minors for which I am responsible to indemnify and hold them harmless (in other words, I agree to pay for...) for all such defense fees and costs.
