1. WHAT INFORMATION DO WE COLLECT?

We collect personal information that you provide to us, such as name, contact details, and account credentials.

- **Google API:** Our use of information received from Google APIs adheres to the Google API Services User Data Policy.

2. HOW DO WE PROCESS YOUR INFORMATION?

We process your information to manage accounts, deliver services, respond to inquiries, fulfill orders, and protect our Services from fraud.

3. WHEN AND WITH WHOM DO WE SHARE YOUR PERSONAL INFORMATION?

We may share data during business transfers (mergers) or when using Google Maps Platform APIs to provide location services.

4. DO WE USE COOKIES?

Yes, we use cookies and similar technologies (like Google Analytics) to analyze site usage and assist with basic functions.

5. HOW LONG DO WE KEEP YOUR INFORMATION?

We keep your info for as long as you have an account with us or as required for legal/tax purposes.

6. HOW DO WE KEEP YOUR INFORMATION SAFE?

We use a system of organizational and technical security measures; however, transmission is at your own risk.

7. DO WE COLLECT INFORMATION FROM MINORS?

We do not knowingly collect data from or market to children under 18 years of age.

8. WHAT ARE YOUR PRIVACY RIGHTS?

You can review, change, or terminate your account at any time. You have the right to withdraw consent and opt out of marketing communications.

9. DO-NOT-TRACK (DNT)

We do not currently respond to DNT browser signals as there is no uniform standard. However, we do honor Global Privacy Control (GPC) signals.

10. U.S. SPECIFIC RIGHTS

Residents of states like NJ, CA, VA, and others have specific rights to access, delete, and correct their data. We do not "sell" your personal information in the traditional sense.
